The proposed project involves a portion of the site known as the existing County Administration Center, or CAC site, in the City of Santa Rosa in Sonoma County. The project site is bounded by Bicentennial Way to the north, Administration Drive to the south, Mendocino Avenue to the east, and Highway 101 to the west. The County proposes to replace portions of the CAC to include one office building, a single-story structure to house the Emergency Coordination Center (ECC), covered surface parking with a solar microgrid, and up to 1,500 residential units. The office building would be approximately 250,000 square feet, up to six stories in height. The building would house up to approximately 1,200 full-time employees and accommodate up to approximately 18 additional employees compared to existing conditions. The ECC would be a new single-story building that measures approximately 7,000 to 13,000 square feet. The project would also include up to 1,500 residential units (with up to 70 percent affordable residential units) within multiple buildings with maximum heights of seven stories. It is possible that one or more of the residential buildings would also provide commercial/retail space on the ground floor.
